

## Local Option Levy on the May 21<sup>st</sup> Ballot & Construction Update

### Local Option Levy on May 21<sup>st</sup> Ballot

The Lebanon Fire District is currently seeking support for a local option levy, known as Measure 22-202, ahead of the May 21st ballot. First, it's essential to address why the Lebanon Fire District cannot utilize funds from the previous \$16 million station bond to hire more firefighters. State laws prohibit the use of bond funds for purposes other than those specified in the bond language, which was for station construction. Operational and personnel costs, including hiring firefighters, are typically covered through levies, which must be renewed every 5 years.

If Measure 22-202 passes, it will authorize the allocation of tax revenue to fund six additional firefighters and new equipment. This measure is aimed at improving response times, enhancing operational capacity, and broadening non-emergency services.

The rationale behind the Lebanon Fire District's proposal to hire more firefighters stems from the increasing demand for emergency services in our area. Current firefighters are already stretched thin, often working overtime to meet this demand. Paying overtime can be more expensive than hiring additional full-time positions.

Additional firefighters mean shorter response times to emergencies. With increased staffing, the Lebanon Fire District can address emergencies more promptly, preventing delays that may occur when all units are committed to simultaneous calls. This increases the likelihood of positive outcomes in emergencies.

Considering the financial impact on homeowners, if Measure 22-202 passes, it would result in a cost of

\$0.75 per \$1,000 of assessed property value. For instance, a home assessed at \$200,000 would incur an annual fee of \$150, which is \$12.50 monthly.

### Construction Update

I'm pleased to provide an update on the Station 31/Headquarters construction project, approved by voters in 2019.

When the district sought voters' approval for the bond in 2019, we made two commitments. Firstly, we pledged to eliminate the existing \$800,000 debt on the remaining Station 34 bond—a promise fulfilled in early 2020. This accomplishment was pivotal in upholding our second commitment, which was to limit the new bond cost to 34 cents per \$1,000 of assessed property value. We are delighted to announce that we have not only met but also surpassed both promises, delivering a bond cost below the anticipated expense at 33 cents per \$1,000 of assessed property value.

Two common questions from the community are about the timeline and budget of the construction.

Following the bond approval in November 2019, the fire district promptly began the project by hiring an architect and initiating station design. However, the COVID-19 pandemic in early 2020 caused disruptions in the construction market, leading to increased material costs and longer lead times. Recognizing these challenges, we decided to pause

the project temporarily to await more stable market conditions.

During this time, our team continued to work diligently behind the scenes. We hired a contractor and collaborated closely with the architect to find ways to align the project with our budget. By delaying the project and focusing on cost-saving measures, we were able to stay within the budget parameters outlined in the bond, albeit with a longer timeline.

## Prevent. Prepare. Protect: Wildfire Awareness Month



Annually, human-caused wildfires make up 87% of all wildfire incidents nationwide.

May is wildfire awareness month! Practicing wildfire mitigation protects you, your loved ones, and your property from fire hazards. Here is a home ignition zone checklist that outlines simple steps from the roof to the foundation, which can significantly enhance a home's safety against embers and radiant heat.

- Clean roofs, gutters, and exterior attic vents to remove debris that could catch embers.
- Repair or replace damaged roofing materials and window screens to prevent ember penetration.
- Install 1/8 inch metal mesh screening on vents and below decks to reduce ember intrusion.
- Clear flammable materials from around your home, such as mulch, plants, and firewood piles.
- Remove stored items from beneath decks or porches.

## Open Burning Season: Information and Guidelines



Stay safe during open burning by knowing the rules, checking the weather, and having fire safety gear ready.

Domestic or residential burning is prohibited in special open burning control areas except for burning yard debris between March 1<sup>st</sup> to June 15<sup>th</sup> and October 1<sup>st</sup> to December 15<sup>th</sup>.

- **Hours:** Open burning is permitted only between 7:30 am and two hours before sunset.
- **Daily Announcements & Restrictions:** Before domestic or residential burning, check restrictions by calling the Linn County Burn Line at (541) 451-1904 or viewing the Willamette Valley Open Burning Announcement at [www.skmngt.com/burn.php](http://www.skmngt.com/burn.php).
- **Materials Illegal to Burn:** It is illegal to burn asbestos, asphalt or industrial waste, automotive parts (including frames), dead animals, plastic and rubber products, tires, waste oil, petroleum treated and related materials, wet garbage and food waste, or any material creating dense smoke or noxious odors.
